Dear Regan:

I am pleased to begin implementing the pilot program permitting Macon County attorneys to by-pass security screening at the Courthouse.

Enclosed is the Special Access Agreement which must be signed by any attorney who wishes to participate in the program. I would ask that the signed Agreement be returned to my office no later than Friday, July 24.

Commencing Monday, July 27, attorneys who have submitted their signed Agreement may call Laura Lents at the County's Printing and Purchasing Department to schedule a time for a photograph to be taken and the Special Access card issued.

Ms. Lents may be contacted at 424-1302. Her office is located in Room 315 of the Macon County Office Building at 141 South Main Street. A fee of \$10.00 will be due before the Special Access card is issued. No card will be issued until the Special Access Agreement has been signed and delivered to my office. If the pilot program is successful, an annual renewal fee of \$5.00 is anticipated.

Special Access cards will be honored by Court Security officers beginning Monday, August 3. I look forward to working with the Bar to make this a successful program.

## MACON COUNTY COURTHOUSE

## SPECIAL ACCESS AGREEMENT

The undersigned certifies that he or she is an Illinois-licensed attorney in good standing with no pending disciplinary proceedings and with a principal office in Macon County, Illinois.

By requesting special access credentials for use in the Macon County Courthouse, the undersigned agrees as follows:

- 1) Special access shall be terminated if the attorney is no longer licensed to practice law in Illinois, is subject to disciplinary proceedings, or no longer maintains a principal office in Macon County.
- 2) Special access is not transferable, nor can it be extended to non-attorneys in the company of the attorney granted special access.
- 3) Special access passes must be displayed to court security personnel prior to by-passing regular security check-points.
- A) No weapons or other contraband may be brought into the Macon County Courthouse by an attorney granted special access.
- 5) Upon the request of any court security personnel an attorney granted special access may be required to proceed through regular security screening.
- 6) Special access for an attorney may be suspended or withdrawn at any time by the Sheriff or Presiding Judge without prior notice, hearing or appeal.
- 7) The undersigned agrees to pay the reasonable cost of issuance of a special access card, and annual renewal fee as established by the Presiding Judge.
